Comcast Contract & Ordinance

J. Crossen explains that the shorter, more flexible version of the Cable Franchise ordinance was advertised on September 13th. J. Faust made a *motion to pass Ordinance 2019-3 as presented*. Second by J. Heim. Voted all in favor. J. Crossen also mentions information he received in an email earlier today from the FCC regarding a change in the rules for how fees are generated. This is expected to go into effect this Fall. Board decides to table signing of Comcast Franchise Agreement until more details are received.

Faust also reports on a conversation he had with Verizon and says they will be prorating the bills of those affected while internet service was out for 8 days. 2019 Ballots for Election of Trustees

J. Heim made a motion to appoint Michael E. Keller to the Pension Trust, Unemployment Group Trust, and Health Insurance Cooperative Trust. Second by T. Strause. Voted all in favor.

Health Insurance Renewal

Rate will increase by 6.1%. Kathy Farr-parker recommends we stick with current plan. J. Faust made a *motion to stay with current health insurance plan for 2020*. Second by T. Strause. Voted all in favor. J. Heim abstained.

Floodplain Updates

B. Baldwin explains that FEMA makes these updates every 3-4 years. J. Crossen is looking at our penalty phase. What level of restrictiveness do we want? Currently at the minimum level, as is most of the County. Change isn't taking place until next May. Board decides we will stay at the least restrictive rate as we like letting the property owner make their own decisions instead of us mandating what they must do. B. Baldwin says this really comes into play when financing a home.

Forest Management & Timber Harvesting Publication

A pamphlet and sample ordinance ideas was received. B. Baldwin and J. Crossen will look into but this appears to be industry-driven, though we do want to be compliant with state code.
